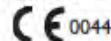

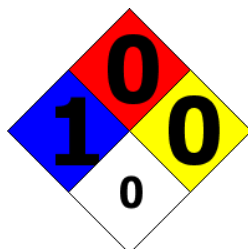

Description of first aid measures

Eugenol can impair the polymerization of the composite and cause discoloration.
